Invitation to participate in the New Product Technology Session

The small engine technology conference (SETC) has contributed to the development of small engine technology by holding numerous technical discussions as an international conference on small engines since the first time was held in Milwaukee in 1989. Society's expectations for academic societies are to contribute to the promotion of technology and related businesses and encourage human resource development. In order meet this expectation, SETC has expanded the scope of its technical field to include not only engine technology but also product technology equipped with an engine such as vehicle technology. In recent years toward decarbonization, SETC has incorporated electrification technology and technology for utilizing renewable energy such as hydrogen and synthetic fuels.

Along with such changes in the target technology area, the name of the conference was changed from the Small Engine Technology Conference to the Small powertrain and Energy systems Technology Conference in 2020, and efforts have been made to increase the value of the conference. In the second, in order to further revitalize the conference and promote development and exchange of human resources, SETC2022 will introduce an online participation system to attract more participants from around the world.

We hope that you will use this opportunity of the New Product Technology Session to promote your company's products and encourage technology development.

What is the New Product Technology Session?

The New Product Technology Session will introduce a wide range of new products, services, manufacturing devices, development tools including software and other new items from technical perspective.

In the technical field handled by SETC, the various products and services are produced around the world every day, and the latest technologies are used to enhance customer value. This session will focus on the technologies that make them possible, and will show the superiority and novelty of functions, performance advantages, and value proposition related to the products and services. Leading to further technological evolution and value creation are expected through this session.

Note: Automobiles, Large Vessels, Large Aircraft, Locomotives, and Spaceships are out of the subject.

New ideas or hints may be found by discussing about the products or services with the participants of SETC.


By combining presentations and exhibitions, presenters from exhibitors can introduce their products in more detail.

NPTS presentation will be held in the exhibition hall equipped with 500 inch large screen, 200 seats and exhibition area.


Presentation time is 20 minutes and Q & A 10 minutes.


